QUESTION ONE

Refer to Text A, "One way and another", on page 2 of the resource booklet.

Discuss how the writer explores the ways people respond to the details of life, referring to at least TWO specific aspects of written texts.

Sometimes lifes simple pleasures create some of the fondest memories, even if they are unconventional. The writer displays of this explores how people respond to the details of life, that was moments in our lifes that are bizarre or unideal may become our most cherished or exciting memories. The writer of this text is reminded of the shower he used to have that would run either hot or freezing cold by the irregular weather patterns.

"It used less water in than a b Eventually we got a shower above the both with taps that lunched from freezing straight to boiling point. It used less water than a bath but gave a contradictory nod towards a notion of extrovagance". The words adjecting "freezing" and "boiling point" contrast each other and create an image in the readers that this new shower was a jarring and un pleasent experience. This juxtoposes the word "extravagance" which is an adjective with positive connotation that makes the reader think of luxury, even though the shower does not sound luxurious at all the juxtaposition of these two ideas is used by the author to explore the idea that the simpler times in our lives where the most simple things seemed extravagant often make us feel grateful for what we have now.

"And now again today, soching in the sun and rain, the steamy air I goze through brings back early memories of unreliable but swanky showers"

Words with positive connotations such as "soalling" "sun" "steamy" and "gaze" are used by the author to show us that reminiscing an old times is making him feel calm and blussful. These words also have sibilance, creating a calm 'ssh' sound that may remind the reader of raindraps fulling. This betps as to and these techniques are used in combination to portray a happy and positive tone from the writer. This is used to explore the idea that looking back on simpler memories often makes us feel calm and greateful

The writer of this text uses all these techniques to explore that the details of our lives that were simpler, where we may have even struggled and where the most loosic things seemed extravagant or lyxurious may be some of our most cheristred memories. We look back on them with joy or excitement because they make us feel grateful for what we have now and teach us to appreciate the small pleasures of life.

QUESTION TWO

Refer to Text B, "What's in a name?", on page 3 of the resource booklet.

Discuss the ways the writer explores the significance of naming, referring to at least TWO specific aspects of written texts.

This text explores the idea that a last name is a part of you, and that when you wanten get married, it is not fair that you should have to a change your last name that you have had your whole life to commit to your husband, but the man can keep his own last name and not be affected. name changing situation is in fact not equal, then this word eludes to the fight for equality between men and women that has been going on fan throughout history. These techniques work to gether to suggest that it is not fair that men do not have to change their identity or go through the 'nightmare' of name changing like women do.

"But of least we are Rawhide-Canals together, radically committed over an equally shared burden of choice made on an even playing field." The adjective together has a positive connotation and is associated with teamwork and gagreement. This sh is used by the outhor to show that this is what marriage should be about, sharing a name and committing to each other equally, rather than the woman changing their name while the mon stays the same.

The writer uses all these techniques to explore the significance of a last name; that it is a part of our identity, if we share our last name with our spouses equally (as she did with a double barrellast name) it shows that we are equally committed to each other and we now share a part of each others identity.

QUESTION THREE

Compare how the writers reflect on people's experiences of change, referring to at least ONE specific aspect of written texts used in each text.

the writer of Text A and Text B reflection change differently. In Text A, the writer looks backon change from the past the present as a reason to be thankful for his life now. "Stunningly nonsensical. How can this be happening right in the middle of a summer's day while here I am only a single generation from a time when the only shower In all our street was a cold one..." The author uses the was adverb "stunningly" and the adjective "nonsensical" next shower to epachather almost as an oxymoran to show how much his life has progressed in previous years. He is impressed and excited at how much his life and the conditions of the lives of people around him have improved text A shows how people reflect how some people experience positive change, which makes us happy and grateful.

Text B, the writer looks loach on the change from her expectations in the 80's to what life is now. not changing your name when you got married seemed to me then an obvious choice; a simple thing you could to to make a big statement about womens equality... That was 30 years age and it appears it hasn't become the norm a tall" Past tense and the adjective obvious is used to show the reader how the writer had big expectation for feminism in the 80s.

The verb cuppears, shows us that the an thormas mistaken, that her views have now changed and that her hopes had not become reality.
"I got anary that about being made to feel as if I was the only one to who had to againse over a choice that felt like it not only had implications for me. " words like "angry" "againse" and "implications" all have negative connotations and create a change in the authors tone. Showing that her disappointment has led to anger which will encourage her to make a change. The writer of Text B has felt that womens equality has regressed. Text B shows that negative change leads to negative emotions but this encourages people to make a change.

The authours of Text A and Text B reflect on people's experiences of change differently. Text A reflects on the idea that positive change encourages us to be grateful for what we have. Text B reflects on the idea that regative change encourages as to take action and change our lives. Both Text A and Text B reflect that all peoples experience of change, positive or negative can be good in the long term, because both encourage teach as lessons about life.
