















































This portfolio was verified and placed in the lower end of the Merit grade range as it clearly fulfilled the criteria by:

- using media, techniques, and illustrated elements at an appropriate level
- presenting a number of options within the proposition to drive the portfolio forward
- · establishing a proposition that allows for purposeful decision making
- using hand-drawn elements and photographic components
- exploring compositions and options; decisions are clearly related to purpose
- establishing a clear aesthetic using a mood board of visual elements
- using clear design devices (e.g. the use of shape, line, pattern, and texture) that enable the candidate to explore multiple options and also help the readability of the work
- generating original imagery that continues to further the investigation and advance the ideas.

To sit more securely in the Merit range, the portfolio would need more evidence of:







This portfolio was verified and placed in the upper end of the Merit grade range as it clearly fulfilled the criteria by:

- establishing a proposition that clearly displays the purpose of the investigation
- engaging with production early on and advancing it, evident in the way they use font, shape, form, gradient, sound bar, sound wave device, and symbolism
- using font choice creatively and as a form of imagery within the brief
- using colour in a refined manner.

To be awarded Excellence, the portfolio would need more evidence of:

- further adaptation of the logo, to advance ideas in distinct new or diverse directions. This would show regeneration.
- design that considers the scale and space allocated to briefs The size of the VIP brief has limited the opportunity for extension. This is a common trend with candidates trying to attempt product design to show the clarification, extension, and regeneration that is required for excellence.
- regeneration within the briefs and/or across the briefs. Excellence boards tend to be consistently inventive within the parameters of their proposition.
