




S-03 SOUTH ELEVATION 1:50





M5	This set of working drawings clearly communicates the technical details of the design. The drawings include plan views, elevations, cross section, and enlarged construction details. The floor plans, elevations, and cross sections are well connected through accurate labeling and cross-referencing.	
	The plan views communicate technical details in the form of room fittings, door swings, and windows, however, the wall thickness in the floor plans use an insulation convention which the CAD program may have automatically put in. This convention should have been indicated by a solid (black) fill instead. The elevations indicate exterior materials, windows, and doors, and also provide some vertical dimensions of the height of the building and its features. The cross section, drawn at 1:50 conveys technical details clearly, and is well linked to their location on the floor plans.	
	This set of drawings lacks informative and coherent information for Excellence due to errors with the details and accurate referencing of information. There are two details labelled as number 1, but each is in a different location and elevation. If labelled correctly they should also be showing significantly different information. The eave detail, number 3, should show weatherboard as the cladding, not brick. At the location indicated, the eaves/soffit area does not include the wall framing or cladding.
