Question	Sample Evidence
(a)	Possible evidence for why access to contraception in sub-Saharan Africa is an international concern.
	Internationally, people should not have limited access to safe and easily accessible contraception that is affordable. Safety and accessibility of contraception has a huge impact on health, quality of life, and poverty caused by unwanted pregnancy. The inability to access safe contraception impacts on society internationally through cultural stereotypes, inadequate health services, marginalisation, employment opportunities, and general negative well-being.
(b)	Possible evidence of how determinants of health influence access to contraception in sub-Saharan Africa and how it affects people and society.
	An example of a health determinant that could affect society is Economic. The cost of affordable contraception is outside of many people's economic capacity within sub-Saharan Africa. Contraception is expensive and therefore difficult to obtain for the majority of people affected by poverty. This then impacts on people, as they may become pregnant with an unwanted child which impacts on them financially but also emotionally. There are also implications for society as overpopulation is a problem for a country that lacks economic resources to cater for its existing population. Causing extreme poverty and other issues such as lack of adequate food and other issues including poor health care caused by overcrowding.
(c)	Possible evidence for a national strategy in a sub-Saharan African country that addresses a determinant of health mentioned in part (b).
	Economic and political determinants can be addressed if the sub-Saharan African Government prioritises access to contraception by subsidising how people in rural communities access contraceptive methods could be achieved by setting up health provider services that deliver contraception to rural areas. An example of this can be seen in Resource F where Rwanda boasts an innovative idea where a start-up company delivers contraceptives to villages by moped. The contraceptives can be ordered by text message, just as in Kenya where 20,000 people are already using the service.
(d)	Possible evidence for an international strategy that addresses a determinant of health mentioned in part (b).
	Economic and political determinants can be addressed if health professionals from more affluent countries lobby the contraception companies, such as those who produce condoms, to provide contraception at a subsidised rate to sub-Saharan African governments. This would allow them to provide these for the people who are struggling to afford contraception. Some of the profits made by contraception companies that produce contraception such as condoms in more affluent countries could be used to subsidise this. This is similar to the work that is being done by the Bill and Melinda Gates Foundation where they lobby within Western countries and raise funds to distribute in sub-Saharan Africa for better access to sexual health services for women to help improve their life expectancy and life chances, such as education and employment.
