Purpose

This qualification is intended for people with basic knowledge and skills in Ngā Mahi ā te Whare Pora who would like to broaden their knowledge, skills, and competence in raranga, tāniko, taonga tākaro, and whatu.

The requirements for the selection of Ngā Mahi ā te Whare Pora standards have been deliberately left non-prescriptive to enable providers to offer a package that can focus on a specific area of weaving that is appropriate to the needs of their learners and the local whānau, hapū, iwi or community. A balance of credits may be chosen from anywhere in field Māori to broaden the learners' skills and knowledge in te ao Māori.

This qualification builds on the National Certificate in Ngā Mahi ā te Whare Pora (Pae Tuatahi) (Level 2) [Ref: 0705], and pathways to the National Diploma in Ngā Mahi ā te Whare Pora (Pae Tuatoru) (Level 5) [Ref: 1640].

Special Notes

Tikanga pertinent to the mana whenua is interwoven through all practices of Ngā Mahi ā te Whare Pora.

Transition Arrangements

Version 3

Version 3 was issued following the review of the qualification.

Changes to structure and content

- The credit requirement for the qualification was decreased from 120 to 80.
- Elective 2 was removed leaving only one Elective section (previously Elective 1) and a Balance (previously Elective 3).
- The credit requirement for the Elective was decreased from 80 to 60 credits.
- Exemptions were updated with classifications to reflect the intended exemption relationships.
