Purpose

This qualification is for people either new to the Clothing Manufacturing industry, or already working in it. It is designed to recognise the skills and knowledge required by a basic cutter.

The qualification is structured in two sections. The standards in the compulsory section are industry specific standards recognising the necessary trade skills and knowledge, and complementary personal skills at this level. Elective standards recognise a wider range of industry specific skills. This qualification recognises a mixture of generic industrial skills and specialist skills that can be used to progress into a variety of roles within the industry.

This qualification provides a basis for further education and training leading to the National Certificate in Clothing Manufacture (Cutting) (Level 3) [Ref: 0822].
