Purpose

This qualification is for people working in the clothing industry as basic embroidery machinists in the apparel industry.

The qualification comprises a compulsory section and an elective section. The standards in the compulsory section are industry specific recognising the specialist embroidery skills, trade knowledge, and complementary personal skills required at this level. Standards 17914 and 17915 in the compulsory section are common to other Competenz qualifications. The elective structure of the qualification allows trainees, providers and employers the flexibility to tailor programmes to meet individual skill needs.
