Purpose

The National Certificate in Beauty Services (Body Therapy) (Level 5) is awarded to people who have demonstrated the skills and knowledge required to perform a range of beauty services at a professional level within the commercial environment. Holders of this qualification are able to consult with a client, establish the needs of the client on the basis of consultation, sell beauty goods and services to meet client needs, conduct the prescribed service in a professional manner, and maintain communication with the client. In particular, holders of this qualification are able to perform, as an independent beauty services operator:

- a figure analysis
- a Swedish body massage
- heat and electrical body services.

This qualification and National Certificate in Beauty Services (Electrology) (Level 5) [Ref: 1048] have credits in common.

This qualification is a progression from the National Certificate in Beauty Services (Cosmetology) (Level 3) [Ref: 0631], some of whose credits can be used for this qualification. This qualification in turn could lead to other qualifications in Beauty Services such as the National Certificate in Beauty Services (Beautician) (Level 4) [Ref: 1046]; the National Certificate in Beauty Services (Nail Technology) (Level 4) [Ref: 1047]; and the National Certificate in Beauty Services (Electrology) (Level 5) [Ref: 1048]. Some credits achieved for this qualification can also be used for these other Beauty Services qualifications.

Replacement information

This qualification replaced the Body Therapy strand of the National Certificate in Beauty Therapy (Level 4) with strands in Beautician and Nail Technology, Body Therapy, and Electrology [Ref: 0632].

Transition Arrangements

Version 2

Version 2 was issued to remove the expiring *Core Health* standards and to give effect to the transfer of standard setting responsibility for the standards in the *Beauty Therapy* domain and the associated qualifications to the New Zealand Hairdressing Industry Training Organisation Inc.

Changes to structure and content

- The credits for standard 497 increased from 1 to 3.
- The expiring *Core Health* standards 12701, 12703, 12707, 12709, 12714, 12716, 12720, 12721, 12723, 12727, 12729, and 12732 were removed.
- The remaining standards in the elective section (standards 513, 516, 517, 518, 519, 520, 521, 522, 523, 1096, and 19603) were moved to the compulsory.
- The overall credit requirement for the qualification changed from 106-113 to 111.

Previous version of the qualification

Version 1 of this qualification replaced the Body Therapy strand of the National Certificate in Beauty Therapy (Level 4) with strands in Beautician and Nail Technology, Body Therapy, and Electrology [Ref: 0632].

Changes included: removal of standards 1277, 1978, 6403, 6405, 6406, 6408, and 10386; the inclusion of substantially the same content in the reviewed *Beauty Services* standards, to achieve a more explicit focus on the beauty services environment; deletion of standard 10391, *Demonstrate knowledge of exercise programmes for the adult client in beauty therapy*, which was identified in the standards review as no longer relevant to the beauty services industry; inclusion of generic *Core Health* alternatives for the *Beauty Therapy* anatomy and physiology standards.

This version of the qualification contains standards that replace earlier standards. For the purposes of this qualification people who have gained credit for the expiring standards are exempt from the requirement to gain credit for the replacement standards.
