### **Purpose**

This qualification is for people who wish to machine shear crossbred sheep at a sustained output in the New Zealand wool harvesting industry.

All standards in this qualification are compulsory because shearing contains a set of well-defined skills and knowledge that apply across all woolsheds.

Holders of this qualification are able to make accurate judgements on the best gear for sheep conditions; adjust style to maintain the required output, fluency and quality; and build on rhythm and timing to improve average shearing rate. The qualification also recognises the knowledge and skills required to prepare, maintain, and service shearing gear, a shearing handpiece, and shearing plant.

It is recommended that before embarking on this qualification, candidates have either completed the National Certificate in Wool Harvesting (Junior Shearer) (Level 2) [Ref: 1547] or have the appropriate prior skills and knowledge required in order to cope with the demands of this qualification.

This qualification is part of a series developed for the wool harvesting sector. A qualification pathways diagram can be found at the end of this document.

This qualification is a part replacement for the Machine Shearing Junior and Machine Shearing Intermediate strands of the replaced National Certificate in Shearing [Ref: 0571].

#### Version 2

Version 2 was republished to provide an exemption from Ref: 1547 for people who have gained award of the replaced qualification, Ref: 1050, with one of the shearing strands.

Version 2 was issued to update content following review of the wool harvesting industry standards and qualifications in September 2009.

Changes in structure and content

- The classification in the title has changed from Shearing to Wool Harvesting.
- Credits for standard 20103 decreased from 15 to 10 leading to a decrease in total credits from 115 to 110.

The standards and qualifications for the wool harvesting sector were reviewed in 2003. This qualification is one of seven new qualifications that replaced the National Certificate in Shearing with strands in Machine Shearing Junior, Machine Shearing Intermediate, Machine Shearing Senior, Blade Shearing Intermediate, and Blade Shearing Senior [Ref: 0571]. This qualification is a part replacement for the Machine Shearing Junior and Machine Shearing Intermediate strands.
