Purpose

This qualification recognises the entry level skills and knowledge of a person working in, or planning on working in, the aquaculture sector of the seafood industry. While all holders of the qualification will have achieved at the same level, flexibility within the structure of the certificate allows different sectors of the aquaculture industry to tailor programmes to meet the skill needs of employees and employers.

The qualification is comprised of two elective sections. Elective One allows candidates to choose the relevant entry level skills and knowledge from the Aquaculture domain that apply to their proposed career path. Elective Two allows candidates to complement the choices made in Elective One with related skills and knowledge that support their current role and/or proposed career path. This flexibility allows for recognition of the range of skills and knowledge, both practical and theoretical, required in the aquaculture sector.

This qualification provides a pathway to the National Certificate in Aquaculture (Level 3) [Ref: 1620].

Transition Arrangements

Version 3

Version 3 was issued following a review of the qualification. The Aquaculture advisory group (consisting of industry experts, workplace assessors, and education provider assessors) consulted on the credit size, flexibility, fitness for purpose, industry endorsement, use and completion of the qualification.

Changes to structure and content

- Structure was updated from a compulsory and elective section to two elective sections.
- Overall the credit total reduced from 62 to 40 credits.
- Compulsory standard 497 was moved to Elective Two.
- Expiring first aid standards 6400, 6401 and 6402 were replaced by standards 26551 and 26552 and the subsequent exemptions were included.
- Standards 1754, 10851 and 10852 were added to Elective Two.
- Standards 6213, 16340, 16337, 16672, 16673, 17253, 17254, 19851, and 19852 while no longer specified in the qualification can still be used to meet the elective requirements.

All new trainees will be enrolled in programmes leading to the new version of the qualification.

People currently enrolled in programmes leading to version 1 or version 2 may either complete that version or, transfer their results to version 3.

This qualification contains standards that replace earlier standards. For the purposes of this qualification, people who have gained credit for the expiring standards are exempt from the requirement to gain credit for the replacement standards – see table below.

Previous versions of the qualification

Version 2 was issued following a review. There were minor changes made to ensure the titles and credits listed were accurate, and to remove the requirement to use the current level and credit values of Aquaculture standards regardless of the version held by the candidate.

Version 1 of this qualification replaced the National Certificate in Aquaculture (Oyster Farming) [Ref: 0648], the National Certificate in Aquaculture (Mussel Farming and Harvesting) [Ref: 0658] and the National Certificate in Aquaculture (Abalone Farming) [Ref: 0764].

The main changes from the review included: combining the three qualifications into one; inclusion of health and safety and first aid standards; inclusion of species specific biology and industry overview standards; allowing for flexibility in terms of options for skill specific standards.
