## **National Certificate in Aquaculture Diving (Level 4)**

### **Purpose**

This national certificate recognises the skills and knowledge of an aquaculture industry diver. It is designed to recognise the specific aquaculture task related skills and knowledge required by divers, who already have diving qualifications, to carry out their job. The holder of the qualification is able to carry out a range of aquaculture related tasks while diving on a marine farm.

The compulsory section recognises knowledge of health and safety, legislation and the application of industry best practice guidelines to aquaculture guidelines. The elective section recognises the specific aquaculture diving skills that are relevant for a role as a diver in the aquaculture industry.

People who have gained the National Certificate in Aquaculture (Level 2) [Ref: 1063] or the National Certificate in Seafood (Level 3) with the optional Aquaculture strand [Ref: 0906] may choose to work towards this qualification. This qualification builds on the diving skills recognised by the National Certificate in Diving (Foundation Skills) (Level 3) [Ref: 1321].

# **Special Notes**

The majority of standards in the Aquaculture Diving domain have prerequisites that have expired. Of these, most do not form part of this qualification, but are contained in the National Certificate in Diving (Foundation Skills) (Level 3) [Ref: 1321].
