Transition Arrangements

This replaced qualification version 2 was republished in September 2017 to extend its last date for entry into training programmes from 31 December 2017 to 31 December 2018.

This qualification has been reviewed and replaced by the New Zealand Certificate in Commercial Road Transport (Specialist Driver) (Level 4) with strands in Transportation of Logs, Heavy Haulage Transportation, Livestock Transportation, Dangerous Goods Transportation, Waste Transportation, General Cartage, and Groundspreading [Ref: 3091].

The last date for entry into programmes leading to the replaced qualification is 31 December 2018. The last date to meet the requirements for the replaced qualification is 31 December 2019.

People currently working towards the replaced qualification may meet its requirements by the date specified or transfer their results to the replacement qualification.

It is anticipated that no existing candidates will be disadvantaged by these transition arrangements. However, anyone who feels that they have been disadvantaged may appeal to MITO at the address below. Appeals will be considered on a case by case basis.

Purpose

This qualification is for people who drive heavy combination vehicles transporting logs. It shares some compulsory standards with the National Certificate in Goods Service (Heavy Vehicle Driver) with strands [Ref: 1228]. It can therefore build on the knowledge and skills in that qualification or be achieved independently. Both qualifications are part of a suite of transport qualifications designed to provide a career path for drivers, from new entrants to the industry to highly skilled drivers of vehicles carrying specialised products.

The compulsory standards ensure that the driver has the knowledge and skills for the safe, lawful, careful, and efficient transport of logs by road. The elective section allows candidates to choose standards specific to their role and/or organisational needs, such as loading a logging truck and/or trailer, transporting logs by overdimension heavy combination vehicle in an off-highway environment, and operating vehicles involved in forestry operations.

This qualification provides a pathway to higher level national certificates including the National Certificate in Road Transport Management (Operations) (Level 4) [Ref: 1209] and the National Diploma in Road Transport Management [Ref: 0961].

Special Notes

This qualification does not permit the holder to drive a motor vehicle on New Zealand roads. To drive a motor vehicle legally, the driver must be the holder of the appropriate current driver licence of the Class for the vehicle. The NZ Transport Agency issues driver licences.

This qualification replaced the National Certificate in Commercial Road Transport (Logging Truck Driver) [Ref: 0942].

Transition Arrangements

Version 1

This qualification replaced the National Certificate in Commercial Road Transport (Logging Truck Driver) [Ref: 0942].

Version 1 of this qualification was republished to include reverse transition arrangements for expiring standards 6400-6402 and 22215.

Differences between the qualifications

- The replacement qualification has a new title.
- Elective sets A, B, C, and D were replaced with a single Elective set in the replacement qualification.
- Standard titles, levels, and credits were updated.
- Standard 24089 was substituted for Compulsory standard 15164.
- Compulsory standard 17373 was moved to the Elective.
- Elective standards 13108 and 13109 were replaced by standard 22294.
- Standards 62, 64, 1277, 1735, 1766, 3483, 3501, 4260, 6929, 16609, 17459, 17592, 17972-17974, and 18077 were not included in the replacement qualification.
- Standards 15408 and 22150 were added to the Compulsory.
- Standards 6928, 6935, and 22215 were added to the Elective.
- Elective standards 3462, 3465, 17577, and 17677 were moved to the Compulsory.

While the exemption for standard 24089 is valid for the purpose of completing this qualification, it should be noted that if a candidate does not already hold a Class 5 driver licence, they will need to complete standard 24089 in order to satisfy current NZ Transport Agency requirements for that licence.

As there are substantial differences between the new and replaced qualifications, it is recommended that people currently enrolled in programmes leading to the award of the National Certificate in Commercial Road Transport (Logging Truck Driver) [Ref: 0942] complete that qualification. However, they may transfer their results to this qualification if they choose.

The last date for entry to the National Certificate in Commercial Road Transport (Logging Truck Driver) [Ref: 0942] is 31 March 2009. The last date for assessment for the National Certificate in Commercial Road Transport (Logging Truck Driver) is 31 December 2010.

People currently enrolled in programmes leading to the National Certificate in Commercial Road Transport (Goods Service) with the Log Transport Strand [Ref: 0680] (reviewed March 2006) may also wish to transfer to this qualification. The last date for assessment for the National Certificate in Commercial Road Transport (Goods Service) with the Log Transport Strand is December 2011.

It is not intended that anyone is disadvantaged by this review, and the above arrangements have been designed for a smooth transition. Candidates should contact NZ Motor Industry Training Organisation (Incorporated) at the address below if they feel disadvantaged by the transition arrangements.
