## National Certificate in Whakairo (Te Ara Tauira) (Level 3)

### Purpose

This is the first in a suite of four whakairo qualifications, and is designed for students in the secondary sector beginning study of whakairo. The emphasis in this qualification is on exploring, examining and applying ideas, processes, conventions and concepts of whakairo.

People awarded this qualification will have an understanding of the progression of whakairo from an introductory level to developing foundation skills in the art of whakairo.

The compulsory section focuses on the study of carvings and literature to interpret meaning, creating and developing visual ideas of carving and applying core skills to develop basic whakairo objects. The elective section of the qualification is designed to encourage students to acquire additional skills which will enable them to explore, and apply ideas and concepts of whakairo in other subjects of study, which may include maths, te reo Māori, tikanga a iwi, performing arts, tech drawing, or computing.

This is an introductory qualification that may lead to further study of whakairo and the National Certificate in Whakairo (Tūturu) (Level 4) [Ref: 0521], the National Diploma in Whakairo (Level 5) [Ref: 0745] and the National Diploma in Whakairo (Level 6) [Ref: 0746]. This qualification may also lead to the National Certificate in Māori (Te Ngutu Awa) (Level 4) [Ref: 1006].

The credits from the Level 1 standards in this qualification may be used towards gaining the National Certificate of Educational Achievement (NCEA) (Level 1) [Ref: 0928].

The credits from the Level 2 standards in this qualification may also be used towards gaining NCEA (Level 2) [Ref: 0973] and the National Certificate in Māori (Te Waharoa) (Level 2) with optional strands in Reo Māori, Māori Performing Arts, Whakairo, Ngā Mahi a Te Whare Pora, Reo Māori Media, Te Whakamahi Whenua [Ref: 878].

The credits from the Level 3 standards in this qualification may also be used towards gaining NCEA (Level 3) [Ref: 1039].
