Evidence must be provided of one quote and one estimate, each for a different large or complex project.

Examples of projects that may be used include (but are not limited to) manufacture or repair of: vehicle and marine upholstery, boat covers, convertible tops, tonneau covers, protective covers, clear enclosures, carpets, tarpaulins, tents and marquees, screens and blinds, awnings, shade sails, canopy structures, tension membrane skins and textile structures.

Definitions

Complex projects – projects that have a level of complexity in their production, e.g. multiple materials to be sourced, advanced technical skills required, coordination of other agencies or contractors, multiple components or parts to the product.

External customers – a customer who purchases a company's projects but is not an employee or part of that company.

Industry guidelines – those practices and procedures commonly used as standard procedures to produce items of acceptable saleable quality in the industrial textile fabrication or trimming industry such as related textbook descriptors.

Internal customers – a person or department inside the company who needs the assistance of another part of the company to complete their job, e.g. a sales, engineering or installation department.

Large projects – projects that have additional production requirements due to their size or volume, e.g. high quantity of material, high labour needs, large production area.

Manufacturer's information – technical information for a machine or product detailing operation; installation and servicing procedures; manufacturer instructions; technical terms and descriptions; and detailed illustrations.

Workplace requirements – instructions to staff on policy and procedures that are available in the workplace. These requirements may include – company policies and procedures, work instructions, product quality specifications and legislative requirements.

Ihirangi waitohu | Indicative content

- The difference between an estimate and a quote.
- Components of plans created to enable the costing of projects, such as risk assessment, production timeline, material accessory, labour and resource costs.
- Factors to consider when estimating or quoting for producing a product, such as material costs, labour-charge out rate(s), sub-contractors, overheads, production costs attributable to the product, profit margin, GST.
- Process for creating a quote:
 - Use details from the customer approved concept to create a plan for costing in accordance with company processes and documentation.
 - Describe the factors that affect profitability, including efficiency, productivity, rework, staffing levels.
 - Identify the consumer related legislative requirements that need to be met when estimating or quoting.
 - Describe workplace operating requirements relevant to estimating or quoting for a product.
 - Estimate or calculate the relevant costs for an estimate or quote.
 - Apply profit margin to the production cost and calculate GST on the selling price, if appropriate.

- Record total estimate or quote price and prepare estimate or quote, using your company procedures and documentation.
- Check and confirm estimate or quote with a supervisor.
- Present estimate or quote to internal or external customer for sign off.
