Pārongo aromatawai me te taumata paearu | Assessment information and grade criteria

Assessment specifications:

Candidates must be capable of consistently carrying out day-to-day flooring tasks to commercial standards.

Commercial standards refer to:

- performing the skill in a safe manner
- performing the skill to the required industry standard
- perform the skill within an acceptable timeframe
- repeat the skill on demand.

Appropriate behaviour may include being punctual, reliable, dependable, consistent, interacting courteously and respectfully, communicating effectively, collaborating, paying attention, dressing in accordance with workplace expectations.

Environmental protection procedures may include managing the disposal of waste, including dust, plastics, off-cuts.

Health and safety procedures refer to any hazards which may be encountered on a flooring job.

Industry standards must reflect flooring industry best practice, workplace procedures, and be within acceptable tolerances as defined in New Zealand.

Legislative frameworks refer to the relationship between legislation and other relevant components to achieve the purpose of Acts as they relate to flooring tasks.

Standards of work relates to the regulatory requirements, industry and workplace current practice, and the behaviour expected of a tradesperson working in a commercial environment.

Relevant components may include Rules, local council bylaws, Standards, Approved Codes of Practice, and best practice guidelines relating to flooring trades.

Candidates must be capable of maintaining standards of work in at least one of the flooring trades:

- carpet flooring
- resilient flooring
- timber and composite flooring
- flooring planning and design
- resin flooring
- flooring surface preparation.

Assessment must reflect workplace conditions and meet workplace health and safety requirements.
