Pārongo aromatawai me te taumata paearu | Assessment information and grade criteria

Assessment specifications:

Candidates must be capable of consistently applying topical coatings to concrete flooring surfaces to the standard expected of commercial competence.

Application of topical coatings includes evidence of a two-component coating and at least two of:

- paint
- sealer
- polish
- polyurethane.

A two-component coating may include epoxy, polyurethane, methyl methacrylate, polyester.

Topical coatings do not include waterproofing systems, resin toppings, underlayment, or cementitious systems.

Commercial competence refers to:

- performing the skill in a safe manner
- performing the skill to required industry standards
- performing the skill within a commercially viable timeframe
- repeating the skill on demand
- performing the skill without supervision
- applying the skill to other work.

Industry standards must reflect flooring industry best practice, workplace procedures, and be within acceptable tolerances as defined in New Zealand.

Workplace procedures refer to verbal and written information covering company policy, standard operating procedures, and job specific instructions.

Assessment must conform to workplace conditions and meet workplace health and safety requirements.
