Whāinga   Purpose	This skill standard is for people intending to complete qualifications and credentials in the painting and decorating trades.  People with this skill standard have the skills to apply coatings using spray painting systems to the level required of a commercially competent painter and decorator.  This skill standard aligns with the New Zealand Certificate in Painting and Decorating (Level 4) with strands in Spray Systems, Wallcoverings and Specialised Coatings [Ref 3568].

	d. Minimal wastage and areas of remedial work is achieved through application of coatings.

3. Maintain spray system equipment.	Spray equipment is dismantled, cleaned and maintained in accordance with worksite requirements.

Assessment specifications:

The candidate must be capable of applying and finishing coatings using spray painting systems to the standards expected of a commercially competent painter.

Spray painting systems may include:

airless

- air-assisted.
- high-volume, low-pressure (HVLP).

Evidence is required of competence different spraying methods and must include competence of application of coatings using spray systems on doors, windows, skirtings, walls, ceilings, roofs and exterior cladding systems.

Commercial competence requires a candidate to be capable of consistently performing the requirements of the skill specification:

- to current regulatory, industry and commercial standards
- within a commercially viable timeframe
- in commercial environments
- without supervision
- in different and unfamiliar contexts.

- Spray painting equipment and accessories, and checks for serviceability and security.
- Spraying techniques for different surfaces, including doors, windows, skirtings, walls, ceilings, roofs, exterior cladding systems.
- Safety instructions, dust and ventilation management, signage and barricade requirements.
- Application to different surfaces and substrates.
- Reinstalling doors.
- Procedures used to clean work area and dispose, reuse or recycle materials.
- Procedures used to clean spray equipment and accessories.
- Environmental requirements and impact in application.
