- mana whenua, mana moana.
- data collection may include oral interviews, written questionnaires, written surveys, visual and audio recordings, records of observations.
- integrity may include tikanga, kawa, karakia, appropriate permissions, intellectual property is protected, acknowledgment of sources, record of consultations, availability of data and analysis for mana whenua.
- kõrero tuku iho is used in relation to Māori stories, or Māori histories and can be found in oral traditions for example ngā pūrākau, pakiwaitara, whakapapa, karakia, waiata, karanga, whai kõrero or in written literature, concepts, whakataukī and whakatauākī.
- basic use of te reo and karakia.
