The scope of performance for this standard is limited to what would be expected to deliver structural detailing for a construction project. The construction project will have the following characteristics:

• Range of resources – involves a limited range of resources for example people, data and information, natural, financial and physical resources and/or appropriate technologies.

- Level of interactions requires the best possible resolution of interactions between limited technical, non-technical, and project issues.
- Familiarity requires application of practical procedures and practices for known operations and processes.

Ideally, evidence for assessment against this standard will be derived from detailing contributions to a single construction project.
