# Pārongo aromatawai me te taumata paearu | Assessment information and grade criteria

For assessment purposes:

- Assessments should reflect the cultural context of Aotearoa New Zealand and the principles of Te Tiriti o Waitangi, contemporary overarching acts, positive youth development frameworks, including Mana Taiohi and Code of Ethics for Youth Work in Aotearoa New Zealand.
- This skill standard may require the disclosure of personal information. This information must be treated according to relevant statutes, regulations, codes of practice, and workplace policies and procedures.
- Taiohi can be defined in this skill standard as either one young person being supported, or a group of young people being supported.
- Taiohi should be supported for at least six weeks.
- For assessment criterion 3d, evidence of at least two goals, two social aspirations and two cultural aspirations per taiohi must be identified.
- Evidence for meeting learning outcome 3 must be gathered in a youth work setting.
- Evidence for this standard must reflect best practice in youth work including legal, cultural and ethical considerations. Practice must follow organisational policies and procedures.

#### Definitions:

- Taiohi refers to young people between 12 and 24 years old.
- Tangata whenua refers to the "people of the land" or the indigenous Māori people who have ancestral ties to a specific area, region, or territory within New Zealand.
- Te Tiriti o Waitangi is the agreement between the British Crown and Māori in New Zealand to establish a common set of laws or agreements for the British settlers and Māori people to live together. It comprises of two documents: one in English and one in te reo Māori.

- Te Tiriti o Waitangi articles kāwanatanga, tino rangatiratanga, and ōritetanga.
- Treaty of Waitangi principles partnership, protection, and participation.
- Māori language, culture, traditions, and practices.
- Historical and present attitudes in Aotearoa towards discrimination, racism, sexism, homophobia, and whaikaha (disabilities).
- Impacts of the colonisation process on tangata whenua.
- Application of Te Tiriti o Waitangi articles at organisational level (planning, policy, service provision, staffing) and at individual level (relationship with tangata whenua, relationship with tauiwi, service delivery).
