- Assessments should reflect the cultural context of Aotearoa New Zealand and Te Tiriti o
  Waitangi articles, contemporary overarching acts, positive youth development frameworks,
  including Mana Taiohi and Code of Ethics for Youth Work in Aotearoa New Zealand.
- This skill standard may require the disclosure of personal information. This information must be treated according to relevant statutes, regulations, codes of practice, and workplace policies and procedures.
- Evidence for the practical components of this skill standard must be generated in a youth development setting.
- Evidence for this standard must reflect best practice in youth work including legal, cultural and ethical considerations. Practice must follow organisational policies and procedures.

#### Definitions:

- *Professional obligations* refer to codes of conduct, confidentiality requirements, duty of care, and the legal and ethical frameworks that govern the profession.
- Safeguarding procedures refer to organisational guidelines covering risk and its mitigation, and can include informed consent processes, chaperoning, and making taiohi aware of safeguarding information.
- Supervision refers to professional and/or external supervision with a qualified 'supervisor'.
- Taiohi refers to young people between 12 and 24 years of age.
- Youth work practice is a mana-centric relationship between a youth worker and taiohi, where
  taiohi actively participate, discover their power, and choose to engage for as long as agreed; and
  that supports their holistic, positive development as taiohi that contribute to themselves, their
  whānau, community and world.
