**Pārongo aromatawai me te taumata paearu** | Assessment information and grade criteria For assessment purposes:

- Assessments should reflect the cultural context of Aotearoa New Zealand and Te Tiriti o
  Waitangi articles, contemporary overarching acts, positive youth development frameworks,
  including Mana Taiohi and Code of Ethics for Youth Work in Aotearoa New Zealand.
- This skill standard may require the disclosure of personal information. This information must be treated according to relevant statutes, regulations, codes of practice, and workplace policies and procedures.
- Evidence for the practical components of this skill standard must be generated in a youth work setting.
- Evidence for this standard must reflect best practice in youth work including legal, cultural and ethical considerations. Practice must follow organisational policies and procedures.

#### Definitions:

- Community services (for youth work) refer to external individuals, organisations, or institutions
  that collaborate with youth work practitioners and agencies to support positive development and
  wellbeing of young people. These partners can be from various sectors, including government
  agencies, non-profit organisations, schools, businesses, healthcare providers, community-based
  organizations, faith-based and other youth-serving entities.
- Positive youth development is an approach or philosophy that guides communities in the way
  they organise services, supports, and opportunities so that all young people can develop to their
  full potential.
- Taiohi refers to young people between 12 and 24 years of age.
- Youth work practice is a mana-centric relationship between a youth worker and taiohi, where taiohi actively participate, discover their power, and choose to engage for as long as agreed; and that supports their holistic, positive development as taiohi that contribute to themselves, their whānau, community and world.
