- to current and relevant Legislation, Standards, and Codes (including safety),
- in an environmentally sustainable manner,
- within an acceptable timeframe,
- in different and unfamiliar contexts.
- with acceptable behaviours.

#### Ihirangi waitohu | Indicative content

Planning and Preparing the Site:

- Interpreting project plans and coordinating with stakeholders to align site setup with requirements.
- Verifying site boundaries, existing features, and service locations using surveying tools.
- Setting up access points for greenfield sites, existing residential or commercial sites, and multistorey buildings.

#### Establishing site facilities:

- Installing power and water supplies for site operations.
- Setting up storage sheds, perimeter fences, hoarding, and temporary facilities such as toilets and washrooms.
- Creating meeting/assembly points, hazard boards, and wash-down areas.
- Ensuring emergency preparedness by placing signage for nearest defibrillator, first responder contacts, and safety plans.

#### Managing waste materials:

- Positioning and managing skips for general waste and recycling.
- Handling hazardous waste safely and responsibly.
- Implementing runoff control systems like silt fences, water detention tanks, and socks.
- Designing processes to reduce waste, reuse materials, and recycle efficiently.

- Implementing weather protection measures and securing hazardous materials.
- Organising material storage to avoid damage and prevent obstruction of work areas.

#### Site disestablishment:

- Steps for waste disposal, removal of temporary facilities, and performing remedial work to restore the site.
- Preparing and issuing project close-out documents.
- Seeking feedback from stakeholders and making improvements for future projects.

#### Site security:

Installing and maintaining fences, signs, and security systems to protect the site and equipment.

#### Coordination and management:

- Use of a construction work plan to coordinate subcontractors and delivery schedules.
- Maintaining a workable site throughout the project by managing movements and resources effectively.

#### Access management:

- Managing access for various site types.
- Greenfield sites with no existing infrastructure.
- Existing residential and commercial sites with operational constraints.
- Alterations in multi-storey buildings requiring vertical access solutions.

#### Protection and environmental considerations:

- Collaborating with neighbours to minimise disruption.
- Preserving historically or culturally significant features during site activities.
- Implementing environmental measures to reduce impact on surrounding areas.

Health and safety implementation:

- Locating and maintaining the Site-Specific Safety Plan (SSSP).
- Regularly checking and updating safety resources, including first-aid kits, defibrillators, and emergency contacts.
