Pārongo aromatawai me te taumata paearu | Assessment information and grade criteria**Assessment specifications:**

To achieve this standard the candidate must be capable of carrying out internal lining installation tasks for a plaster board sheet product, and one other lining type, under limited supervision to industry standards.

Industry standards must reflect industry best practice, workplace procedures, and be within acceptable tolerances as defined in New Zealand codes, regulations and standards.

Plans and specifications can include working drawings, plan specifications, manufacturer specifications, installation instructions and work, demolition and project plans.

Under limited supervision refers to candidates carrying out the requirements of this skill standard with basic guidance and indirect supervision from a suitably skilled tradesperson. They are expected to source some information independently from plans, specifications, or relevant New Zealand Standards.

This standard may be assessed in the workplace or a simulated work environment.

Evidence for this standard must be demonstrated:

- to current and relevant Legislation, Standards, and Codes (including safety),
- in an environmentally sustainable manner,
- within an acceptable timeframe,
- with acceptable behaviours.

Types of Linings

- Plasterboard, reconstituted wood, fibre cement, timber panelling, plywood, profiled metal.

Properties of linings

- Material composition, sizes, shapes, profiles, edges, finishes, grades, durability.
- Features such as moisture resistance, sound control, and fire resistance.

Framing considerations

- Check for flatness, straighten as needed, and remove any protrusions.
- Verify appropriate framing spacing based on the type of lining being used.

Setting out and preparation

- Sheet orientation and positions.
- Calculating material requirements and layout control joints.
- Internal bracing elements.
- Pre-line inspection requirements.

Safety considerations

- Work safely at heights, identify and avoid wires and pipes, and use appropriate PPE.

Calculations

- Quantities of materials, fixings, and jointing compounds.
