**Pārongo aromatawai me te taumata paearu |** Assessment information and grade criteria Assessment specifications:

- Learning outcome 1 must be aligned with the local Civil Defence and Emergency Management (CDEM) group plan and hazard profile.
- Assessment criteria 2a includes the likely supports available after three days and one week.
- Assessment criteria 2c support role description is in accordance with learner's organisational requirements and a person-centred approach.
- Assessment criteria 2d collaboration provided is person-centred and addresses specific needs
  of an individual and or the collective needs of families, whānau and or community.

#### Definitions:

- Community refers to a group of people connected by location, culture, e.g. iwi Māori, workplace or institution, shared experience and or interests.
- Iwi Māori Te Arawhiti, the Office for Māori Crown Relations, acknowledges that multiple
  organisations or groups may represent an iwi. These can include rūnanga (tribal councils), postsettlement governance entities, mandated iwi organisations, hapū, marae committees, whānau,
  kaupapa Māori organisations.
- Person-centred readiness acknowledges that each individual's circumstances are unique, that
  people are the experts of their own lives, but may need support to develop and implement
  personalised readiness plans.
- Priority populations refer to individuals or groups who are at higher risk of harm, adverse outcomes, or barriers to accessing support before, during, or after an emergency or disaster. Increased risk factors may be due to physical, social, economic, or cultural factors.

### Ihirangi waitohu | Indicative content

- Naturally occurring or man-made hazards including earthquakes, floods, heat, landslides, storms, tsunami, volcanic activity, wildfires, and others.
- Consequences of natural hazards relevant to New Zealand's hazard profile.
- Consequences of local and large-scale events relevant to diverse communities: geography, culture, socioeconomic status and access to resources.
- Approaches to supporting community readiness: whānau centred and person centred.
- Community-led engagement inclusive of Te Tiriti o Waitangi.
- Defining own role supporting individuals, families, whānau and communities.
- Preparing to support others to be ready for an emergency: understanding key roles in the response and local support sources.
- Legislative frameworks relevant to readiness: Civil Defence and Emergency Management Act 2000, Health and Safety at Work Act, 2015, and the National Disaster Resilience Strategy.
- Readiness plans responding to likely consequences of hazards and needs of individuals, families, whānau and communities.
- Culturally responsive, person-centred readiness plans with targeted support for priority populations.
- Readiness plans inclusive of where individuals, families, whānau and communities might be located in the event of an emergency; what resources they have access to; and who they are responsible for.
