#### Assessment specifications:

Guarding may be carried out armed or unarmed.

Evidence presented for assessment against this skill standard must be in accordance with enterprise procedures.

#### Definitions:

*CBRN* refers to chemical, biological, radiation, and nuclear.

Reference to *enterprise procedures* means that all activities must comply with the requirements contained in the current relevant legislative and/or regulatory requirements, which includes but is not limited to: New Zealand Defence Force (NZDF) Policy.

*IED* refers to improvised explosive device.

*Unprepared aircraft operating area* refers to a location lacking designated airport facilities, for example buildings, perimeter fences, electricity.
