AS90538, Te Reo Rangatira 3.3 Pānui

- This achievement standard has been replaced by two distinct achievement standards with new titles AS90786 and AS90789, Te Reo Rangatira (3.3 and 3.8).
- The credit values for both AS90786 and AS90789 have been reduced from 4 to 3 credits.
- The mode of assessment for the new Te Reo Rangatira 3.3 is internal.
