The NZ Motor Industry Training Organisation (Inc) (MITO) has completed the review of the qualification and unit standards listed above.

Summary of review and consultation process

The National Certificate in Manufacturing (Leatherwork) with strands in Saddlemaking, and Leather Goods Manufacture [Ref: 0471] has only ever been awarded once since it was first registered in 1998 and there are currently no active enrolments. MITO reviewed the qualification and determined that it is no longer fit for purpose and should be designated category D expiring.

Following consultation with the Industrial Textile Fabrication industry, as part of a major qualifications review, MITO designated all unit standards in the *Leather Goods Manufacture* and *Saddlemaking* domains as expiring. The domains were also designated as expiring (lapsing).

Review of *Manufacturing* qualification

Main changes resulting from the review

The following qualification is no longer required by industry. This qualification will expire at the end of December 2011 and will not be replaced.

Transition

Review of *Leather Goods Manufacture* and *Saddlemaking* unit standards

Main changes resulting from the review

All of the reviewed unit standards were designated expiring and not replaced. The *Leather Goods Manufacture* and *Saddlemaking* domains were also designated as expiring (lapsing).

There were no candidates enrolled in programmes leading to assessment against these unit standards, so no transition arrangements were required.

Category D unit standards will expire at the end of December 2011.

Impact on existing organisations with consent to assess

Organisations with consent to assess can continue to assess against these unit standard up until 31 December 2011. No new consents to assess will be granted.
