#### Review of Dairy Manufacturing qualification

## National Certificate in Dairy Manufacturing (Risk Management) (Level 3) [Ref: 1517]

The New Zealand Industry Training Organisation has completed the review of the qualification above.

#### Date new version published

February 2011

The next qualification review is planned to take place during 2015.

#### Summary of review and consultation process

This qualification has been reviewed to allow for the inclusion of technical skills and knowledge as well as skills and knowledge in specialised operations. An optional strand in advanced product safety has also been included to enable candidates to increase their knowledge and skills in this area. This amendment will provide candidates, who would previously have been enrolled in the National Certificate in Dairy Manufacturing (Technology) (Level 3) with an optional strand in Process Improvement [Ref: 0027], with a learning pathway, as the qualification is due to expire at the end of 2011.

The changes were endorsed by the Dairy Advisory Group, made up of industry representatives and providers, in August 2010.

# Main changes resulting from the review

- Change has been made to the title to reflect changes made to the structure and content
  of the qualification.
- Electives A and B have been amended to include and remove standards and classifications.
- An optional strand has been added.

Changes to structure and content

- Title has been amended.
- Credit total has been increased from 40 to 44.
- Electives A and B have been renamed to the Technical Operations Elective and the Specialised Operations Elective respectively.
- Standard 19986 has been added to the Compulsory section.
- Additional standards and domains have been added to the elective sets.
- Standard 20005, and the following domains, were removed from the qualification: Core Health, Non Specialist Security Functions, Public Sector Compliance Management, Security Staff Services, and Safety Legislation for Energy and Chemical Plant.
- An optional strand in Advanced Product Safety has been added.

### **Transition**

People currently working towards version 1 of the qualification may either complete its requirements by 31 December 2012 or transfer their results to version 2 of this qualification.
