The Forest Industries Training and Education Council (FITEC) has revised the superseded versions of the qualifications listed above that have a last date for assessment of 31 December 2012.

Reason for the revision

The qualifications were reviewed in August 2008. Ref: 0703 was replaced by the National Certificate in Forest Foundation Skills (Level 2) with strands in Establishment, Pruning, Chainsaw Operations, Breaking Out, and Landing Operations [Ref: 1410]. Refs: 0702, 0704, 0828-0830, 0832, 0835-0837 were designated expiring and not replaced as they no longer met the needs of industry and new qualifications were developed that met current industry requirements. The majority of candidates enrolled in the expiring qualifications were transitioned into the replacement or new qualifications; however those who had almost completed were encouraged to complete. At that time, it was envisaged that existing candidates would be able to complete their programmes and be awarded the version of the qualification in which they were enrolled. However, the review and expiry of unit standards has created issues for some candidates. In addition, industry now prefers candidates to be assessed against the replacement unit standards rather than the expiring or earlier unit standards.

The qualifications have therefore been amended to enable existing candidates to complete the requirements of the expiring qualifications by adding exemptions from earlier and expiring standards for people with credit for the replacement or acceptable alternative standards.

Main changes resulting from the revision

Credit exemption tables were added to the expiring qualifications, allowing for exemptions from earlier and expiring standards. The exemptions were added so that the qualifications can be achieved until they reach the last date of assessment of 31 December 2012.
