Reason for the revision

Following the transfer of standard setting responsibility for the Masonry subfield from the Creative Trades ITO to the BCITO, qualifications and unit standards within the subfield were revised to include the BCITO as the standard setting body and to update standard details in the qualifications and CMR reference in the unit standards.

National Certificate in Masonry (Bricklaying) with strands in Brick and Block Laying,

and Refractory Installation [Ref: 0454]
