Skills Active Aotearoa Limited has revised the qualifications listed above.

## Date new versions published

#### April 2012

These qualifications are included in the 2012 Targeted review of Qualifications for the outdoor recreation sector.

#### Reason for the revision

The National Certificate in Outdoor Recreation (Instruction) with strands in Adventure Based Learning, Kayaking, Mountaineering, Single Pitch Rock Climbing, and Tramping [Ref: 0733] and National Certificate in Outdoor Recreation (Level 4) [Ref: 1190] have been revised to update reviewed unit standards and replace expiring unit standards to ensure the qualifications remain achievable.

The optional strands in the National Certificate in Outdoor Recreation (River Guide) have been revised to remove unit standard 424 following advice from Maritime New Zealand and endorsement from the New Zealand Raft Association.

## Main changes resulting from the revision

National Certificate in Outdoor Recreation (Instruction) with strands in Adventure Based Learning, Kayaking, Mountaineering, Single Pitch Rock Climbing, and Tramping [Ref: 0733]

Changes to structure and content

- The overall credit total has changed from 53-95 to 45-86.
- Reverse transition added to maintain achievability of version 2.
