## **Summary**

This review, revision and rollover was initiated to ensure these standards remain fit-for-purpose and were considered prior to their planned review date of 31 December 2016. In undertaking the revision and rollover, National Qualifications Services sought feedback on any known assessment issues identified through the national external moderation system and sought feedback from end-users. Unit standard 27700 was identified as requiring minor amendments to ensure it remained accessible as lighting technology changes. Unit standard 27701 required amendments to clarify requirements for merit and excellence grades; and to better reflect the notional hours required to complete. No issues were raised with other unit standards covered by this report.

## Main changes

- The credit value for unit standard 27701 was increased from 3 to 4 to better reflect the notional hours required to complete
- The merit and excellence grades for unit standard 27701 were amended to better reflect the step-up in technique required at each grade
- Definitions for unit standard 27701 were updated
- LED as a type of luminaire was added to the definitions explanatory note of unit standard 27700.
- The maximum number of lighting states was removed from the range of outcomes 2 and 3 in unit standard 27700.
- The legislation explanatory note was amended to refer to the Health and Safety at Work Act 2015.

The last date for assessment of the most recent superseded version of the unit standards is 31 December 2017.
