Summary

Following the development of new qualifications for the hairdressing industry, HITO's Hairdressing Advisory Group reviewed the standards listed above. The review of these standards has resulted in minor changes to update and standardise explanatory notes, range statements, outcomes and evidence requirements. The Advisory Group has endorsed the changes made to the standards.

Main changes

- The titles of standards 2879, 13467 and 25077 were amended to reflect changes made to their content.
- Purpose statements, entry information, explanatory notes, outcomes, evidence requirements, and range statements were updated to ensure they are fit for purpose and to provide clarity for users.

The last date for assessment of the superseded version of these standards is 31 December 2019. Results will not be accepted where the assessment date is after the last date for assessment of the superseded version of the standard.
