Summary

As a result of the Targeted Review of Qualifications process, Primary ITO has reviewed these unit standards to better reflect the requirements of the outcomes listed in new qualifications.

A consultation was held in early 2016 where providers with consent to assess had the opportunity to give feedback via an online survey. This feedback was addressed where appropriate.

Main changes

- 14 unit standards were Category B reviews
- 13 unit standards were Category C reviews
- 26 new unit standards were developed
- Unit standards in the *Fruit Production* domain were reclassified into the *Production Horticulture* domain
- Unit standards in the *Viticulture* domain were replaced with unit standards in the *Production Horticulture* domain
