### Main changes

- Unit standards 6410 and 20078 were extensively amended to reflect current operating realities for small business and were moved to domain *Small Business*.
- Unit standard 6407 was recommended for expiry.
- Unit standard 19024 was replaced by 30388.
- Two new unit standards were developed.

### Category C and D unit standards will expire at the end of December 2019.

The last date for assessment of superseded versions of Category B unit standards is December 2020.
