#### Summary

The unit standards were reviewed to ensure they are fit for purpose, relevant and that their outcomes are achievable and consistent with assessment practices. All amendments to the unit standards were endorsed by the Whakaruruhau.

Three new standards were also developed to reflect what is happening within secondary schools and kura kaupapa Māori, to ensure ākonga gain formal recognition for the work they are presently completing. These standards were also endorsed by the Whakaruruhau.

### Main changes

- Merit and Excellence grades available in new standards 31282, 31283 and 31284.
- Standard 7891 decreased from level 5 to level 4 to better reflect the content of the standard.
- Two standards were reclassified to the *Taonga* domain.
- A last date for assessment against the superseded versions of the Category B reviewed standards has been added.
- Standards were reformatted onto the latest template.
- Standard 29710 had Merit and Excellence grades added; its level was decreased from level 2 to level 1, and its title was changed.
