### **Summary**

As a result of the review of the New Zealand Certificate in Agrichemical Application (Level 4) with strands in Aquatic, Broadacre, Tree and Vine Horticultural, Targeted Weed Control, and Total Vegetation Control [3984-1] Qualification process, Primary ITO has reviewed these unit standards to better reflect the requirements of the outcomes listed in the new qualification.

A consultation meeting was held in August 2019 where industry had the opportunity to give feedback. An online survey was also conducted for the same purpose. Feedback was addressed where appropriate.

### Main changes

- 5 unit standards were reviewed to update guidance information.
- Unit standards were updated to align with the current template.
- Credit value and the level of unit standard 21544 were increased to align with the requirements of an Agrichemical Application programme currently being developed.
