### **Summary**

As a result of the review of the New Zealand Certificate in Primary Industry Skills (Level 2) with optional strand in Self-Management and Employability Skills [Ref: 2218], Primary ITO has reviewed these unit standards to better reflect the requirements of the outcomes listed in the new qualification.

A consultation was held in late September 2018 where providers with consent to assess had the opportunity to give feedback via an online survey. This feedback was addressed where appropriate.

#### Main changes

- 11 unit standards were reviewed to better reflect the requirements of the outcomes listed in the new qualification.
- Industry consultation amendments were made to reflect industry standards to ensure unit standards remained fit for purpose.
