Summary of review and consultation process

Consultation with stakeholders confirmed that the qualifications were fit for purpose and no changes to strategic purpose or graduate outcomes were required.

The results of consistency review meetings were taken into account. Canvassing of industry leaders and representatives of providers and ITOs indicated that only minor changes required by new NZQA templates were called for.

Consensus from stakeholders was obtained for the newly formatted qualifications.

Main changes resulting from the review

The qualifications listed above were reviewed, and version 2 of each qualification was published.

The main changes for all qualifications included:

- Formatting according to new NZQA template
- Minor changes not affecting the intent, have been made to strengthen the graduate profile outcome
- Changing to requirements for consistency from *must* include to *may* include.
