# **Summary**

Unit standards were reviewed with full industry consultation as part of the Competenz scheduled five yearly review.

## Main changes

- Minor changes were made to update terms and definitions and to align unit standards with current industry practices and terminology.
- Industry references were updated for currency.
- Safety and risk management content was updated to reflect current industry requirements.
- Unit standards 6951 and 6952 were designated as expiring and replaced by new unit standard 31982.
- Unit standards 1234 and 1236 had credits raised to better reflect the time to learn the skills involved.
- Unit standard 17767 had its title amended, the level raised from 3 to 4, and credits raised from 10 to 15 to reflect the complexity of the skills required and the time to learn.
