#### Summary of review and consultation process

Feedback from the cleaning industry indicates that the qualifications are fit for purpose and meet the needs of employers and cleaners undertaking training.

The sector confirms that no substantial changes to the qualifications are required beyond the changes identified below.

##### New Zealand Certificate in Cleaning (Level 2) [Ref: 2316]

- Graduate outcomes have been strengthened, without changing the meaning or intent.
- Mandatory requirements for programmes have been removed.
- A *Guidance document for Programme Developers* will be available on Careerforce's website.

##### New Zealand Certificate in Cleaning (Level 3) [Ref: 3025]

- A *Communication* graduate profile outcome (5 credits) has been added at the request of

industry.

- Total credits for the qualification increased to 45-55 credits.
- Graduate outcomes have been strengthened, without changing the meaning and intent.
- Mandatory requirements for programmes have been removed.
