Summary

As a result of the planned Standards Review date, MQS along with the Tourism Māori Whakaruruhau, reviewed the Tourism Māori unit standards to ensure they remain fit for purpose and align with the graduate profile outcomes in the newly reviewed Tourism – Māori suite of qualifications.

Main changes

- Minor title changes to provide clarity for ākonga and kaiako.
- Minor changes to the guidance information section of each standard to ensure consistency and accuracy with tourism definitions.
- Minor wording changes to some outcomes and performance criteria to provide clarity for ākonga and kaiako.
- Standards updated to reflect the latest template and terminology, for example, Guidance Information, Performance criteria.
