Summary of review and consultation process

The review and consultation process began in April 2020. The review group comprised of members from the original qualification development process and members included for their expertise in a specific field of Mechanical Building Services (MBS).

The initial meeting was part of the Sector Advisory Group (SAG) meeting. Considering the degree of collaboration with the development of version 1 of the programme and subsequent launch Oct/Nov 2018 several qualification changes were noted. Due to the Covid-19 lockdown the remainder of communication was via email and online meetings.

Main changes resulting from the review

- Graduate profile outcomes were reviewed for clarity and to meet current technical requirements.
- Conditions relating to graduate profile outcomes were removed in most instances.
- Additional graduate profile outcomes were developed to incorporate the requirements of removed conditions.
- Credit values were reviewed and updated where required.
