#### **Summary**

As a result of the planned Standards Review date, MQS along with the Mau Rākau Whakaruruhau, reviewed the Mau Rākau unit standards to ensure they remained fit for purpose and met the aspirations and needs of whānau, hapū and iwi.

#### Main changes

The main changes that were made to the standards include the following:

- Credit were increased for standards 20953, 20954, 20948, 20949, 27547, 27548, 27549, and 27552 to more accurately reflect the time required to achieve the standard. Kia hōhonu ai te ruku ā he nui tonu ngā mahi i roto i ēnei paerewa.
- 20953 was changed from Level 4 to Level 3
- 27549 was changed from Level 3 to Level 4
- Minor wording changes were made to some outcomes and performance criteria for relevancy, consistency and to provide clarity for ākonga and kaiako.
- Glossary was updated
- Grammatical errors were corrected.

It is the view of Māori Qualification Services that these minor edits do not affect the overall learning outcomes.
