#### **Summary**

The Primary ITO reviewed 25 *Agriculture, Horticulture* and *Primary Sector* unit standards to better reflect the requirements of the updated qualification graduate outcomes.

Level 1 and 2 Production Horticulture unit standards were reviewed according to their planned review date. Unit standard 572 was reviewed in April 2021, while unit standards 22189 and 27207 were reviewed in May 2021, however errors were noted on publication and were revised. Further amendments suggested by industry to selected unit standards were made to ensure they are fit for purpose.

Consultation was carried out in June 2021 where consent to assess holders and stakeholders had the opportunity to give comment on the email sent asking for feedback to amendments. This feedback was addressed where appropriate.

#### Main changes

Reviewed unit standards

- Titles were amended for some reviewed unit standards to better align with the content.
- Unit standard 19139 increased from 1 to 2 credits to reflect the time required to gather evidence to meet the performance criteria.
- Guidance information was amended for unit standards to reflect changes to format requirements.
- Some performance criteria and range statements were amended to ensure unit standards remained fit for purpose.

#### Revised unit standards

- Three unit standards were revised to correct errors noted on publication.
- In unit standard 572 reference to insulating materials in PC1.1 was removed because covered in PC1.2.
- In unit standard 22189 PC4.3 was removed due to the reference of only a portable system.
- In unit standard 27207 an additional performance criterion was included that covers factors which encourage disease prevalence.
