Summary of review and consultation process

Key qualification review, development and consultation phases:

Input and feedback from key stakeholders were invited and incorporated into the review. Key phases in the process included:

- Pre-review survey on Toi Mai's website.
- Exercise Industry Wānanga held in Wellington in September 2022 attended by industry and provider representatives to discuss the current state of the industry, future trends, opportunities and training needs; and identify changes required to existing qualifications.
- Formation of advisory groups followed by advisory group meetings to discuss and receive their feedback and work through the review of the qualifications.
- Open public consultation via the Toi Mai website and through advisory group networks.
- Stakeholder endorsement of review outcomes via email and online meetings.

Main changes resulting from the review

New Zealand Certificate in Freestyle Group Exercise (Level 4)

- Minor change to the strategic purpose statement.
- Minor change to graduate profile outcome wording to better reflect content in a group exercise setting.
- Evidence requirements for assuring consistency statement updated.
- General conditions expanded to include diversity and inclusion statement.

New Zealand Certificate in Pre-designed Exercise Instruction (Level 3)

This qualification is to be expired following stakeholder feedback and evidence of low usage.

New Zealand Certificate in Pre-choreographed Group Exercise (Level 3)

Change report for review of New Zealand qualifications

- Minor change to the strategic purpose statement.
- Graduate profile outcomes wording amended to recognise the differences between delivering group exercise programmes and facilitating group exercise classes, and to better reflect the content around programme specific movements.
- Education pathway updated to remove references to the expiring Pre-designed Exercise Instruction (Level 3) qualification.
- Evidence requirements for assuring consistency statement updated.
- General conditions expanded to include diversity and inclusion statement.
