**Summary of development/review and consultation process**

The extension of the last date for assessment (LDA) of version 1 (and version 2 for [Ref: 2599]) of the above qualifications has been undertaken following a request from and discussions with providers.

This one-year extension of the last date for assessment is to allow providers time to update existing programmes leading to version 1 (and 2 as applicable) of the qualifications. This extension also enables providers to avoid duplication of effort for programme and resource redevelopment.

**Main changes resulting from the development/review process**

- The last date for assessment of the superseded versions of the qualifications, except [Ref: 2591], was

extended from 31 December 2023 to 31 December 2025.

- The Qualification Developer contact details were updated from NZQA National Qualifications Services to Toi Mai Workforce Development Council as required.
