Summary of review and consultation process

Key qualification review, development and consultation phases:

Input and feedback from key stakeholders were invited and incorporated into the review. Key phases in the process included:

- Pre-review survey on Toi Mai's website.
- Exercise Industry Wānanga held in Wellington in September 2022 attended by industry and provider representatives to discuss the current state of the industry, future trends, opportunities and training needs; and identify changes required to existing qualifications.
- Formation of advisory groups followed by advisory group meetings to discuss and receive their feedback and work through the review of the qualifications.
- Open public consultation via the Toi Mai website and through advisory group networks.
- Stakeholder endorsement of review outcomes via email and online meetings.

Main changes resulting from the review

New Zealand Certificate in Sport, Recreation and Exercise (Multi-sector) (Level 3), New Zealand Diploma in Sport, Recreation and Exercise (Multi-sector) (Level 5) and New Zealand Diploma in Sport, Recreation and Exercise (Multi-sector) (Level 6)

- *Multi-sector* has been removed from the title of the above qualifications. Industry and providers were confused on what this meant so removing this word and retaining *sport, recreation and exercise* clarified the content of the qualifications.
- Minor change to the strategic purpose statements.
- Minor changes to the employment and education pathways including removing the expiring Level 4
 qualification.
- Qualification award, evidence requirement and transition statements updated.
- General conditions expanded to include diversity and inclusion statement, and legislation statements updated.
