Minor changes to the outcomes of the qualifications were recommended to clarify their purpose and remove unrealistic expectations.</p> <p>The reviewed drafts were circulated to interested parties and consensus was reached for submission to NZQA for approval</p>

<p>The following were updated:</p> <ul style="list-style-type: none"> Qualification Developer details, version, and review dates. Qualification requirements and programme conditions were included. Strategic purpose statements updated to reflect current practice, without changing the intent. <p>New Zealand Certificate in Catering Services (Level 4) [Ref: 2107]</p> <ul style="list-style-type: none"> Graduate profile outcome 2 credits were reduced. Graduate profile outcome 4 was changed to incorporate three smaller outcomes to better reflect industry practice. Graduate profile outcome 4 credits were increased. Graduate profile outcome 7 was removed as not matching industry practice.
